Membership Agreement 2023

EXPLANATORY NOTE: Warrenton Golf Club (WGC), 129 19th Hole Drive, Warrenton, NC 27589 operates as a Semi-Private golf club. Applicant desires an opportunity to enjoy WGC facilities on a regular basis and obtain certain privileges associated with being identified as a member of WGC. Applicant agrees to become a member on the terms and conditions set forth below. For good and valuable consideration, applicant agrees as follows:

- 1. Member. For purposes of the agreement "Member" shall mean the person/persons identified on the "Warrenton Golf Club Membership Application Form".
- 2. Membership. Upon payment of Membership dues, Membership privileges will be active for ONE year to begin (mm/dd/yyyy) and continue through (mm/dd/yyyy).
 Payment of Membership Fee does not give Member any right, interest or ownership in WGC. Membership privileges are personal to member and may not be sold, transferred or otherwise assigned in any manner.
 WGC may revoke membership if Member violates the terms of this contract agreement. No portion of any fees paid is refundable upon revocation or suspension of the membership, other than as set forth below.
- 3. **Membership Payments**. Upon acceptance of this application, the member becomes liable for dues equivalent to one year membership fees based on type of membership applied for (see paragraph 7 for exceptions). Membership dues may be paid in full upon acceptance of the membership application or monthly as invoiced but not later than the 5th of the month. Membership dues may be paid by cash, check or bank draft (bank draft is completed on 5th of each month). Dues not paid by the 6th of the month may incur a 1.5% finance charge and privileges suspended until the account is brought up to date. Dues are subject to change at discretion of WGC Board.
- 4. Member Privileges: Included are: unlimited golf with paid cart fees, unlimited fitness area use, swimming pool privileges (during season), tennis courts, locker room access (assigned lockers at additional fee), club house facility (beverage locker at additional fee), club house rental at reduced rate, access to Member "ONLY" tournaments and events, and reduced cost for open tournaments and events during the year. Pro Shop purchases may be charged to your member account if account is current on all payments. Account statements for purchases in the Pro Shop must be paid in full upon receipt to remain current. Member Privileges are subject to change at discretion of WGC Board.
- 5. **Membership Types**. WGC offers three (3) types of memberships: Family, Single, and Associate. Initiation fee is \$250 payable upon acceptance.
 - Family Memberships are for an Individual and their legal spouses and dependent children (up to 21 years of age, living at home who are full-time students.) College ID card and/or picture ID required. This type of Membership is \$1,080.00 annually, which includes all of the benefits above in addition to voting privileges during the yearly all member board meetings.
 - Single Membership is an individual person and this type of membership is \$660.00 annually, with benefits the same as a Family Membership.
 - Associate Membership is for a family or individual residing outside of a 60-mile radius. This type of membership is \$720.00 annually, with same benefits but no voting rights.

6. Golf Cart Agreement: I represent that I am familiar with the operation of a golf cart and if rented from the club, agree to return said cart at the end of play in as good condition as received. I agree to hold WARRENTON GOLF CLUB free and harmless from any damages or claims whatsoever arising from my or any member of my family, use of said cart, and further agree to pay for all damages sustained while said cart is in my or my family members' possession. I further represent that I am over 16 years of age.

As a rule, golf carts are allowed on the fairways, however, inclement weather or other conditions may evoke further cart restrictions. The Pro Shop staff will notify Members of any temporary restrictions, but players are expected to refrain from driving golf carts where it may damage the golf course or golf cart. No more than two carts per foursome are allowed unless authorized by the Pro Shop. No more than two riders and two golf bags per cart.

- 7. Exceptions to one year commitment of dues: In the event the Member (a) becomes disabled, sick, or injured for a period exceeding thirty (30) continuous calendar days, (b) is activated for Military service, or (c) is relocated for business more than sixty (60) miles from WGC and more than sixty (60) miles from Member's address set forth on Member enrollment form, WGC may suspend or terminate Member's membership. In the event of disability, injury or illness, Member must provide a doctor's note to WGC. In the event of Military service, Member must provide a copy of military orders from issuing authority. In the event of relocation, Member must provide a copy of a utility bill or other correspondence to demonstrate new domicile. Any prepaid dues will be evaluated by the WGC board and a determination will be made per incident as stated above. A written 30-day notice is required before end date of contract is determined. Decisions will be in the sole and absolute discretion of the WGC Board.
- 8. Monthly Charge Accounts. I understand and acknowledge receipt of the document ("Membership Agreement"). I have had the opportunity to review the terms of acquiring a membership. I agree to pay all fees, dues and other charges for which I am responsible under the terms of this Membership Agreement on or before the due date. I agree to be responsible for all charges incurred by my family members and guests while using the Club facilities. I understand that delinquency in paying any amount due will result in a 1.5% late payment fee on the amount past due. I also acknowledge that delinquent amounts may result in suspension or termination of my charging privileges at the club. I hereby acknowledge receipt of Warrenton Golf Club's Membership Agreement that I have read and understand, and agree to be bound by the terms and conditions thereof, including any amended forms issued from time-to-time by WGC. This Membership Agreement may not be amended or modified, nor shall any waiver of any provision hereof be effective, except by an instrument in writing executed by the undersigned and the Club.
- 9. Member is responsible for providing accurate contact information in order to facilitate timely and accurate communication with the Club.
- 10. Member is aware of security camera use on WGC property and consents to usage of any likeness for marketing by WGC.
